I give my eldest son John Blakey all my reversionary estate called Holly House Estate... with the dwelling house, Barns, Stable ... with five cattle gates in Bainbridge Side Pasture and half a cattle gate in Bardale subject to the Fee farm Rent of Eleven shillings and five pence three farthings and also subject to the legacies hereafter ... to my son Joshua Robinson Blakey twelve months after the decease of my Aunt Elizabeth Gibon of Saffron Walden fifty pounds. And further unto my son William Blakey ninety pounds twelve months after the decease of my Aunt Elizabeth Gibon of Saffron Walden .. and unto my son Thomas Blakey the further sum of Ninety pounds twelve months after the decease of my Aunt Elizabeth Gibon of Saffron Walden. And forty pounds to my daughter Ann Thwaite wife of James Thwaite of Counterside twelve months after the decease of my Aunt Elizabeth Gibon of Saffron Walden .. to daughter Elizabeth Blakey thirty pounds twelve months after the decease of my Aunt Elizabeth Gibon. To my son Joshua Robinson Blakey ninety pounds and to my son William Blakey and the sum of ninety pounds to my son Thomas Blakey and forty pounds to my son Ann Thwaite. And also thirty pounds to daughter Elizabeth Blakey ... And my mind and will is that my son Richard Blakey have all my estate called Thorns House Estate and dwelling house, barnswith five cattle gate in Cragg Pasture and five cattle gates in Bainbridge Side Pasture and five in Bardale...now or late in the occupation of John Lambert as tenant ...subject to the payment of feefarm rent of eight shillings and sixpence half penny and also subject and chargeable with the following legacies ... one Annuity of Eleven pounds to my wife Mary Blakey ... And to pay to my son William Blakey at 21 two hundred pounds ...and until he attains 21 to pay 4% towards his support ...and a further one hundred pounds after the decease of my wife Mary Blakey. And to pay to my son Thomas Blakey at 21 two hundred pound And to pay my son Thomas Blakey the further sum of one hundred pounds after the decease of my wife Mary ...[devises estate at Thorns to wife Mary during her life] Joshua Robinson Blakey to have all my estate called Cragg Ends Estate and with three Cattle gates in Cragg and three in Bainbridgeside and also three in Bardale ... now or late in the occupation of Richard Thistlethwaite as Tenant .. charged with the payment of the feefarm rent of eleven shillings and ten pence half penny and further charged with the legacy of one hundred pounds to my daughter Ann Thwaite wife of James Thwaite of Counterside ... And my daughter Elizabeth Blakey to have the field called Law Close now in my possession with the barn therein ... with one Cattle gate in Cragg...under the feefarm rent of one shilling and four pence.
