First I bequith my soule unto almightie god my maker and redemer And my bodye to be buried in the parishe church yearth of St Oswolde in Askrigge. Item I will yt Jane Metcalfe my wife [should] have ye Orderinge and governmente of all my fermholde goods and cattelles moveable and unmoveable duryng her wydowhead to brynge up my childreng upon suche tyme as they be maryed and come to succoure, or staye of lyvinge (other wyse). Item I wyll yt my sayd fermolde shall remeyne whole unto my son John Metcalfe (except one fermolde of the yerelye rent of sixe shillings eight pence whiche I have given unto my sonne Henrye Metcalfe whome I wolde have to go to an occupation, And yf it forton yt the sayd Henry shalle sett or let the sayd fermolde ye sayd John to have yt before an other) Item I give to my sayd son Henrye one yewe and a lambe. Item I give to my son Francis two gymmers. Item the rest of all my goodes both moveable and unmoveable my debts legaces and funrall expences destcharged and payd, I give unto Jane Metcalfe my wyfe and childreng vz John Metcalfe, Henrye Metcalfe, Francis Metcalfe, xpofer Metcalfe, Barbarye Metcalfe, Isabell Metcalfe, Syssell Metcalfe and Margaret Metcalfe, Whome I make joyntlye my Executors of this my last will and testament These wytnesses Thomas Metcalfe, James Thomson and Francis Thomson.
